Call to Order

The meeting was called to order by NGIS President Matt Krok at 12:22 pm.

Minutes from the 2014 Business Meeting. Motion to approve as written, seconded. No discussion. Vote – all aye.

Treasurer Report: (Gary Johnson)

Gary reported that we currently have more than 100 members and have met our goal. What are the advantages of membership? Online information at NGIS.org, such as conference videos, presentations, and other information.

At the beginning of the calendar year, we had \$14,367.55 in our operating accounts, \$10,300.52 in the grant account, and \$1,529 in our PayPal account. As of yesterday (October 12) we have \$20,639.94 in our operating accounts, \$10,300.52 in the grant account, and \$3,866 in our PayPal account, which will be transferred to the operating accounts. To date, the NGIS 2015 operating expenses have totaled \$2,816. Conference expenses are currently \$21,149.12 and conference income is currently \$33,350. This leaves us with a net gain of \$12,200 pending anticipated expenses (~\$12,680) and anticipated income (~\$1,900). The final anticipated total for the conference is \$1,500-3,000 profit.

President – State of the Society Address (Matt Krok)

Matt said that it's great to see everyone networking here, including attendees, vendors and presenters. Our membership has increased and the conference attendance has increased as well. This is his last term as NGIS President, and he thanked everyone.

Other Reports

CAP Grant Report (Eric Ingbar)

The CAP grant was an FGDC grant for a business plan for the State of Nevada. The business plan has been posted on the FGDC website, and we'll add a link from the NGIS website. The plan includes both parcel and LiDAR data, and is a call for action

and advocacy at the state level. The remaining funds in the grant account are earmarked for sending representatives to the NSGIC conference next year.

2014 NGIS Conference Report (Matt Krok)

The 2014 Conference was held at Sam's Town in Las Vegas. We had 103 registered attendees, with a total of 130 +/- including vendors and volunteers. We had 15 vendors with booths at the conference. The 2014 Conference had a net loss of \$156. NGIS did make a one-time investment in recording equipment totally approximately \$2,700 which was used for that Conference, for this Conference, and which will be used for future Conferences.

2015 Preliminary NGIS Conference Report (Eric Schmidt)

The 2015 Conference has 16 vendors with booths, and 144 registered attendees, with a total of 170 +/- including vendors and volunteers. NDOT brought many attendees. Thank you to the planning committee, we have a great result. Thank you to the vendors, and they make the conference work. Thank you to the Montbleu staff, who have been outstanding in keeping everything running smoothly in this great facility. Thank you to the attendees for traveling, networking, and building the community.

As a reminder, the People's Choice award and Vendor Bingo are still open, and Art's 50/50 drawing is a fundraiser for NGIF. Additionally, there are still t-shirts available for purchase.

Coin Check! Everyone show your Challenge Coin. This is a tradition which began in the military and has migrated to safety and emergency management. Moni Fox designed the NGIS coin and had them made for all of the attendees here.

The next Conference will be in Spring 2017 in Las Vegas.
